15. That the provident Fund Register shall be maintained and the case book completed and shown to the Deputy Director of Education of the zone concerned for verification from time to time.
16. Payment of salary and other admissible allowances to the teaching/non-teaching staff as per ongoing CPC through bank/RTGS.
17. The School shall not increase the rate of tuition fee without the prior sanction of the Directorate of Education, Delhi Admin, and shall follow the provisions of DSEAR 1973 and other instructions issued from time to time.
18. That the violation of any instructions/order/rules and regulations of the Department, shall lead to the withdrawal of recognition of the school immediately.
19. That the school shall provide free and compulsory education to the children as per notification no. 15(172)/DE/Act/2010/69 dated 07.01.2011.
20. That in no case the school funds will be diverted/transferred to any other fund/account of the society. The school funds will also not be utilized by the society for any other purpose other than that of the school.
21. School shall appoint two special educators and submit compliance report in district office.
22. The school shall submit compliance of Rain Water Harvesting System within three months.
23. Other conditions as mentioned in recognition letter usually.
